I eagerly accepted Jock Murray's invitation to review this book, expecting one thing from the title, but finding something quite different. Nevertheless, I did not regret my decision. This book is an original historiographic essay that blends intellectual and social history. I had thought that John Burnham would write about the concept of "profession" as it applied to history; my mistake! Instead, he wrote about the concept of "profession" as it applies to medicine—and how historians have interpreted and dealt with that issue.

This project first appeared as a Garrison lecture, published in the *Bulletin of the History of Medicine*, 70 (1996): 1-24. The investigation has been expanded into six chapters and many short subsections. Burnham appeals with ease to a wide range of sources: language, curricula, conferences, interviews, articles, and books. He discovered that "profession" meant different things to different people over the course of 200 years. At first, it meant simply the collectivity of practitioners of the discipline, the great and small—all men—who comprised it. Osler scarcely mentioned the word, but he and Sigerist both used it in this way.
